The Stated Meeting was called to Order with prayer at 9:00 AM by Moderator Scott Bowerman

(TE, Central PC, Chambersburg), petitioning God's Holy Spirit to guide presbyters in everything they do. Host pastor, TE Anthony Saturno (St. James PC, Mechanicsburg) welcomed presbyters warmly. Moderator Bowerman gave instructions for electronic voting via Zoom.

ACTION

MSP to approve the Docket.

Due to technical difficulties, the first item of business passed without input from Zoom commissioners. Moderator Bowerman asked if there were any Corresponding Members. There were none. He asked if there were any First-Time Commissioners, Pastors, DCEs, or Special Guests. Pat Pepper (RE, 1st PC Carlisle), was recognized as a First-Time Commissioner.

WORSHIP

Presbyters were called to worship with a reminder that God welcomes the dreamers and the doubters, and that wherever one finds oneself on the journey, "there is room for all to gather here. This is God's house." After the singing of *Come Thou Fount of Every Blessing*, Moderator Bowerman called on Presbytery Leader for Governance and Congregational Leadership / Stated Clerk (PLGCL/SC) Kristal Smith for the plenary address. Her message, based on the hymn just sung, was titled *Wandering Hearts*. Liturgy for worship was written by/adapted from Rev. Sarah A. Speed, *A Sanctified Art LLC*, sanctifiedart.org. PLGCL/SC Smith used scripture and lyrics from the hymn to frame and introduce the six workshops that were being offered to equip the saints. Workshops had been advertised in advance, with registration materials.

Transforming Congregational Stewardship

led by TE Ellie Johns-Kelley (Ministry Relations Officer, Presbyterian Foundation) – Sanctuary/ Hybrid Luke 5:8-9: When Simon Peter saw the huge catch of fish, he fell down at Jesus' knees, saying, "Go away from me, Lord, for I am a sinful man!"...Jesus said to Simon, "Do not be afraid; from now on you will be catching people." PLGCL/SC Smith connected this story with "streams of mercy, never ceasing," as it aligns with the theme of generosity. In God's hands, a few becomes many and blessings multiply because God is a God of abundance. This workshop is designed to help presbyters perceive this abundance and share it with the world God loves so much.

Let's Get It Started

led by TE Michael Gehrling (Associate for Recruitment and Assessments, 1001 New Worshiping Communities) – Sanctuary/Hybrid

Matthew 14:28: Peter answered him, "Lord, if it is you, command me to come to you on the water." He said, "Come." So Peter got out of the boat, started walking on the water, and came toward Jesus." A *Sanctified Art* connects this story with "here to rescue me from danger," and PLGCL/SC Smith acknowledged her own connection with the theme, asking "how many sermons have we heard about Peter's boldness in taking a risk as he stepped out of the boat only to be rescued by Jesus with "You of little faith, why did you doubt?" This workshop is designed to spark faith and risk-taking in new venues – be they a new worshipping community or a new venture within an existing community.

Ruling Elder Officer Training 101

led by TE Katy Yates Brungraber (Validated Ministry, Interim Pastor, ELCA Greencastle) – Sitting Room Matthew 16:15-16: Jesus said to the disciples, "But who do you say that I am?" Simon Peter answered, "You are the Messiah, the Son of the living God." PLGCL/SC Smith connected this story with "Praise the mount! I'm fixed upon it, mount of God's unchanging love." As followers of Jesus, we are to continually fix our gaze on him. We need a community of spiritual friends and guides who help us stay the course. In the PC(USA), we set aside REs to assist with the spiritual life of the congregation – spiritual leaders who help us stay fixed upon God's unchanging love and witness to the deep wisdom Peter revealed about Jesus as Christ. This workshop is designed to help REs explore the ministry to which they're called.

Basic Workshop for Clerks and Keepers

led by David Staniunas (Records Archivist, Presbyterian Historical Society) – Library Matthew 18:21: Peter came and said to him, "Lord, if another member of the church sins against me, how often should I forgive? As many as seven times?" Jesus said to him, "Not seven times, but, I tell you, seventy seven." A Sanctified Art connects this story with "teach me" in the hymn – as in "teach me some melodious sonnet...". PLGCL/SC Smith connected that melodious sonnet with the story telling involved with process, administration, and keeping records. This workshop is designed to help Clerks and Keepers tend to written records – the narratives of our life together as partners in Christ's service.

Combatting White Christian Nationalism

led by Moderator Scott Bowerman (Central PC, Chambersburg) - Gym

Matthew 26:40: Jesus came to the disciples and found them sleeping; and he said to Peter, "So could you not stay awake with me one hour? Stay awake and pray that you may not come into the time of trial." Matthew 26:73-74: After a little while the bystanders came up and said to Peter, "Certainly you are also one of them, for your accent betrays you." Then he began to curse, and he swore an oath, "I do not know the man!" At that moment the cock crowed. PLGCL/SC Smith connected these scriptures with "Prone to leave the God I love." The core of our struggle, as St. Paul put it, is that we don't do the good we desire and we despise what we do. We fall asleep, we deny, we betray. This workshop is designed to address this struggle with truth, goodness, and Christ in our country.

Pastoral Issues and Approaches for Deacons

led by TE Howard West (Director of Chaplaincy, Country Meadows Community) – Music Room/ Hybrid John 21:15: Jesus said to Simon Peter, "Simon, Son of John, do you love me more than these?" He said to him, "Yes, Lord, you know that I love you." Jesus said to him, "Feed my lambs." PLGCL/SC Smith connected this interaction with the lyrics, "Here's my heart now take and seal it, seal it for thy courts above." Here is my heart – the center of our being, the core of our words and actions. This workshop is designed to help Deacons wrestle with questions of care for members of our congregations and our communities: How do we show compassion for another? How do we show up for another?

WORKSHOPS / BREAK-OUT SESSIONS

At 9:30, presbyters were released to their workshops and Zoom Break-Out Rooms. After a scheduled Break at 10:30, the meeting was resumed by Vice-Moderator Roz Presby at 10:45. She invited reports from Committee Chairs and Team Leaders, each time giving presbyters opportunity to ask questions.

COMMITTEE AND TEAM REPORTS

Presbytery Leader Search Team

RE Wendell Jordan (Faith Immanuel Presbyterian Church), Chair of the Presbytery Leader Search Team, updated the assembly with the good news that a candidate has been identified and is going through the presbytery's process of meeting first with COM and then with the full presbytery, should the way be clear. An audible buzz of anticipation in the room was accompanied by words of gratitude and prayers for the Team.

Administration Committee

TE Ed Blank (Middle Spring PC), Presbytery Treasurer, presented the 2023 Year-End Financial Report. He informed presbyters that if all churches participated fully in per capita, it would yield \$277,000 toward covering the presbytery's ministry expenses. In fact, only 80% (\$191,000) was received last year. Though per capita giving was down in 2023, the Presbytery is in a good financial position; Treasurer Blank assured presbyters that "all our bills are paid; we are healthy." The Administration Committee seeks to strengthen investments further by changing fund management practices.

Nominating Committee

PLGCL/SC Smith reported that – while there still are a few openings to fill on the Permanent Judicial Commission (PJC), Commission on Ministry (COM), and Committee on Preparation for Ministry (CPM),

the NC brings forward two individuals for consideration by the assembly. Vice Moderator Presby inquired whether there were nominations from the floor. There were none.

ACTION

MSP to elect the persons recommended by the Nominating Committee to serve:

- RE Larry Gildner (Duncannon PC) Commission on Ministry
- RE Lowell Kratzer (Lost Creek P) Permanent Judicial Commission

Stated Clerk [see Stated Clerk Report, attached]

PLGCL/SC Smith directed presbyter attention to the Report of the Stated Clerk that had been included with the meeting materials. The report reflected:

- movement of clergy in and out of the presbytery
- 2022 Session Records Review (39 of the presbytery's 42 churches completed review)
- a full Membership Roll of
 - o 55 Retired Minister Members
 - o 28 TEs engaged in Validated Ministry within the bounds
 - o 16 TEs engaged in Validated Ministry outside the congregation
 - 6 Members at Large
 - Zero actively serving Certified Christian Educators in called Educator positions, and
 - 2 Commissioned Ruling Elders (CREs)
- an Ordination Commission report
- reports submitted to the Office of General Assembly, including Necrology.

She invited anyone with questions about these items to feel free to reach out to her. PLGCL/SC Smith invited the next presenter to come forward.

Camp Krislund

Ms. Lindsay Burkholder (Programs Director, Camp Krislund), confirmed the recently announced resignation of Executive Director, Josh Boyd; his resignation became effective yesterday. Ms. Burkholder gave an update about the camp in this interim time without an Executive Director, and requested prayers, as the summer season fast approaches.

Commission on Ministry [see COM Report, attached]

Bridge Presbytery Leader (BPL) and Teaching Elder Lucy Bowerman drew attention to the COM report that was included with meeting materials, which included documentation regarding COM approval of:

- 8 Covenants of Agreement
- an increase in pulpit supply fees (to \$200) and moderator fees (to \$75), and
- requests from Faith Immanuel PC and Centre PC to form Pastor Nominating Committees (PNCs).

She also highlighted the benefits of the Boundary Training being offered March 6-7 at Silver Spring PC. This boundary training, led by Mr. David Olsen (Executive Director, Samaritan Counseling) will apply to everyone who is an active RE, TE, CCE, CRE, and people under care of CPM.

PROCLAMATION

Presbyters entered fully into a time of worship, with Confession, acknowledging that we're a lot like Peter. "Despite our faith, we make mistakes. Despite our belief, we carry unbelief. Despite our love, we can cause hurt." Presbyters were blessed by the powerful preaching of outgoing Moderator, Scott Bowerman. His timely, sermon, titled *Bored to Death*, was based on Acts 20:7-12, the story of a sleepy person falling out of a window during Paul's sermon. Moderator Bowerman named the importance of youth in the church who find themselves in that half-way in, half-way out, space on the fringe of our worshiping communities, on the edge between staying awake and falling asleep.

RESPONSE – Offering, Installation

Offering in the amount of \$270 was collected for M-28 – a local ministry that helps those who have drug problems and other issues get housing. A video was shown about this ministry; the offering was dedicated with prayer by TE Anthony Saturno (St. James PC, Mechanicsburg).

Moderator Bowerman then installed CRE Roz Presby (Faith Immanuel PC, Lebanon) and TE Janice Tiedeck (Monaghan PC, Dillsburg) as Moderator and Vice Moderator for 2024 with the appropriate questions to them about discipleship and service, and appropriate questions to the assembly about supporting and encouraging their ministry. All parties answered in the affirmative. The Prayer of Installation included the petitions, "Help us to discern where your Spirit is leading. Grant us courage to follow you boldly. May your image be reflected in our diversity..."

Former Moderator Bowerman presented symbols of the Office to Moderator Presby to use in her new role. A Cross necklace and Stole – reminders that it is Christ who calls us into service and walks with us. And a Gavel (on order) to guide the presbytery through our work.

SACRAMENT

The body of Christ then celebrated the Lord's Supper, with the new Moderator and Vice Moderator presiding at the Table. Prayers of petition from the community were offered for:

- saints with serious health struggles and surgeries
- peace in Israel/Palestine and a turning from violence and intolerance here and around the world
- those who are homeless or struggling with lack of affordable housing options
- those affected by winter storms
- church growth
- those entering the call to ordination
- first responders and military personnel

Prayers of praise from the community were offered for:

- the life of Rev. Emily McCachren's grandmother, Ruling Elder Minnie McCachren, who entered the Church Triumphant on January 5, 2024.
- Ron and Terry Martin-Minnich, celebrating their 50th Wedding Anniversary April 19, 2024.
- New members joining churches in our presbytery.

Prayers of gratitude from the community were offered for 46 REs from 21 congregations who faithfully served Christ's Church in the Presbytery of Carlisle and were gathered into the eternal realm in 2023. [See Necrology, part of the Stated Clerk report, attached.] The Lord's Supper was celebrated by intinction; presbyters communed with the saints who served faithfully the Presbytery of Carlisle, who have entered the Church Triumphant and now celebrate with us in Christ's eternal realm.

SENDING

ACTION

MSP to adjourn. With a reminder about the next stated meeting of the presbytery on the evening of May 1, 2024, the meeting ended at 11:58 AM with a Benediction by Moderator Presby. "May you look for God in every face. May you find the courage to get out of the boat, to run to the tomb, and to speak of your faith."
