GOD GATHERS US

Call to Order

After presbyters had enjoyed an on-site meal hosted by Dickinson PC, and been ushered into the worship space by a glorious organ prelude, Moderator Roz Presby (RE, St. Andrews PC, Lebanon) called to order at 6:00 PM this stated meeting of the Presbytery of Carlisle. Zoom tutorial instructions had been provided with the Docket. Instructions were given for clergy and commissioners to be recognized in an orderly manner by the Moderator, and to navigate voting procedures, whether in person or on Zoom.

The theme of the meeting was "celebration." Using Liturgy from Ann Weems' book, *Reaching for Rainbows* ["I Celebrate the Church of Jesus Christ," pp. 57-60, "Balloons Belong in Church," pp. 20-23, The Westminster Press, Philadelphia, 1980], presbyters were encouraged to shake egg shakers whenever they heard the word "celebrate" during the service. (Zoomers could celebrate using the reactions panel). The festive sound of egg shakers punctuated the meeting, starting with "We celebrate this community...where healing and compassion leave no time for self-righteousness, and the lifesustaining love of Christ is evident in the life of the believers."

Welcome, Meeting Instructions and Approval of the Docket

Moderator Presby called forward CRE Neal McCulloch (Dickinson PC, Carlisle), who offered a welcome and prayer of gratitude: "thank you, Lord, as we celebrate all you do for us."

ACTION

MSP to adopt the docket.

Enrollment of Corresponding Members / Intros of First-Time Commissioners, Pastors, DCEs, Guests Moderator Presby enrolled as a corresponding member TE Rick Boyer (Presbytery of Northeast NJ). She acknowledged four first-time commissioners: RE Rich Borcher (St. Andrews PC, Lebanon), RE Woody Jones (St. James PC, Mechanicsburg), RE Sherry Webber-Mains (First United PC, Newville), Phil Gardner (Camp Krislund, Interim Director).

Call to Worship

With the meeting framed in worship, Moderator Presby led an interactive Call to Worship, focusing on celebrating Christ's church "where we dare to standup, where risk runs rampant, and you and I and all Christ's disciples are called upon to follow even when it costs us something precious..." Following the singing of Hymn #389 *Let All Things Now Living*, and Confession, presbyters were assured of God's grace, celebrating places where injustices are righted, pain alleviated, scars erased, tears wiped away, children treasured and nurtured. "Together we celebrate the ways God forgives us and makes us whole." Presbyters then Passed the Peace of Christ.

GOD PROCLAIMS TO US

Scripture Reading and Reflection

Bridge Presbytery Leader (BPL) Lucy Bowerman read Psalm 150 and offered a Prayer for Illumination. Her Reflection was a distillation of gratitude for the past 9 months serving as Presbytery Co-Leader. She spoke of wanting people to have fun while doing the work of supporting our churches and pastors. She described seeing the Spirit of Lord dwelling in the people who serve on the committees. TE Bowerman lifted up the chairs of committees and commissions with which she'd had the most interaction – Finance, COM, New Worship, Nominating – and heralded the way they navigate challenges through all their various duties. In addition to marveling at the talents and dedication of presbytery staff, TE Bowerman expressed great gratitude for her partner, Presbytery Leader for Governance and Congregational Leadership (PLGCL) TE Kristal Smith, noting how, together, they pastored the pastors, brought resources and training to presbyters, and care to those who are grieving. TE Bowerman observed that staff meetings are full of laughter, and, encouraged presbyters to invite some of the 8,000+ members of presbytery to come and see what goes on here.

WE OFFER OUR WORK

Coordinating Council

Vice Moderator (VM) Janice Tiedeck (Monaghan PC, Dillsburg) thanked BPL Bowerman for her faithful work, announced the singing of Hymn #10 *Earth and All Stars*, and called for the Report of the Coordinating Council, presented by PLGCL Smith.

PLGCL Smith directed presbyters to her written report for information items, including the

 - o new requirement: free ANNUAL report, deadline June 30 each year, beginning 2025.
 - o this is not an annual financial or charitable activity report.
 - the report will consist of: organization's name; jurisdiction of the organization's formation; name of at least one director, member, or partner; names and titles of the organization's principal officers; address of the organization's principal office; entity number issued by the PA DOS; online filing will be available at https://file.dos.pa.gov/
 - o each church will need to set up a login to use this service
 - recommended: set up a username that reflects the name of the corporation, and make sure that username and password/s are provided to any successor.
 - failure by the DOS to deliver advance notice to any party, or failure by any party to receive notice of an annual report filing requirement does not relieve the corporation of the obligation to make the annual report filing.
 - o failure to file the annual report will subject the corporation to administrative dissolution/termination/cancellation and loss of the protection of its name.
 - ensure that church corporate records accurately reflect current corporate officers and the correct address so that notices will go to the correct location.

PLGCL Smith brought forward a request of the Session of Capital PC (Harrisburg) to waive term limits as permitted (*Book of Order*, G-2.0404). The Presbytery did this for two other churches in December.

ACTION

MSP to approve the waiver of term limits for officers at Capital PC as determined appropriate by its Session, according to the church's needs and limitations, for the year 2024.

PLGCL Smith then spoke with warmth and appreciation for the gifts TE Lucy Bowerman brought to her role of BPL. While the job description TE Bowerman started with was "not very complete," she was willing to trust God with the rest, beginning in August 2023. TE Bowerman graciously stepped up when there was a need; she now graciously steps away as TE Jamie McCleod steps in as new Presbytery Co-Leader. PLGCL Smith emphasized how TE Bowerman served in the margins, dove into insurance issues, and was a "wonderful conversation partner with our churches and pastors." She blessed the presbytery with her listening heart, discernment, and willingness to explore the unknown.

Administration Committee

VM Tiedeck called upon RE Norma Mateer (Middletown PC), who drew attention to the Treasurer's reports – presented for information – which were located with meeting materials on the web site. Questions should be directed to the presbytery's Treasurer, TE Ed Blank (Middle Spring PC).

RE Mateer also brought forward a motion from the Administration Committee which shows a slight change to PLGCL Smith's 2024 Terms of Call so they align with TE Jamie McLeod's Terms of Call – which were approved in March – as is appropriate for Presbytery Co-Leaders.

VM Tiedeck reminded presbyters that because the motion came from Committee, it did not need a second. There was opportunity for discussion; there were no comments or questions.

ACTION

MP to approve the 2024 Terms of Call for Kristal Smith as presented.

VM Tiedeck led the response: "I celebrate the church of Jesus Christ, whose supportive community holds me, enfolds, me, affirms me, reaches out to me, gives to me, receives from me."

WE OFFER OURSELVES

With the meeting running 20 minutes ahead of schedule, TE Anthony Lorenz (First PC, Carlisle), was invited forward to offer the Commission on Ministry (COM) report. He spoke of the call to ordered ministry in the Church being the act of the triune God, evidenced by the movement of the Holy Spirit in the individual conscience, the approval of a community of God's people, and the concurring judgment of a council of the Church. (BOO, G-2.0103 Call to Ordered Ministry). TE Lorenz presented Shawn Gray who

- has been under care of Lackawanna Presbytery
- graduated from Lancaster Theological Seminary with a Master of Divinity in May of 2021
- is certified ready to receive a call (as of November 2023) by Lackawanna Presbytery
- is voted by the Session of Derry PC as the Temporary Supply Pastor for Christian Education
- was examined by the COM, which now brings Shawn for examination for ordination to the Ministry of Word and Sacrament (MWS) and the position of Temporary Pastor at Derry PC

Candidate Shawn Gray read Acts 9:1-19 — "Saul, why do you persecute me? I am Jesus..." In exploring the text, Candidate Gray admitted that, usually, he is a Lectionary preacher. He observed parallels between Saul/Paul's call to ministry and his own, noting that "Those surrounding Paul affirmed the call," and he was affirmed as well. Using illustrations from the lives of C.S Lewis and J.R. Tolkien, Candidate Gray referred to his camp counseling days and his struggle to say yes to God's call to ordained ministry. His hesitancy came from the worry that he was not good enough. He has learned that whatever inadequacy we have, God can fill those gaps. He figures that if God used a persecutor to write much of the New Testament, God can use him — despite his anxieties of lack of skill. Candidate Gray charged presbyters to be filled with the hope that we are all God's beloved.

Moderator Presby instructed presbyters that the purpose of this examination was to evaluate the Candidate's readiness for ordination to MWS. Appropriate topics for questions related to the sermon, his Statement of Faith and Spiritual Autobiography (provided in online materials for today's meeting), the Bible, Sacraments, Polity, Theology, and his sense of call to Derry PC.

Questions asked and answered included

- How do you get young people to participate? safe space, permeable walls, focus on Christ
- Is camp your passion / niche? Originally, yes, but now, also a desire to convey God's love to all
- What does God do in the sacraments what is God's action? God is present, shows grace
- What spiritual disciplines help you be in communication with God? honor Sabbath, read, listen

- What about Derry PC, specifically, called to you? community for my family; sense of a good fit
- What methods do you use in sermon preparation? lectionary, lectio divina, story (it takes days)
- There's no mention of the Holy Spirit in your Statement of Faith; what you believe? the three in one is a mystery they all have strengths and weaknesses Holy Spirit is not taught. Holy Spirit is God's action in the world; an electricity that moves us, the Breath of God ethereal. Holy Spirit is feminine in gender. God's hands and feet.
- How do you see your role as one of the millennials in the presbytery? we're the bridge
 generation, bridging the days of pre-internet and card catalogues with modern technology
 Candidate was encouraged by presbyters to add into his Statement of Faith his heliefs about the

The Candidate was encouraged by presbyters to add into his Statement of Faith his beliefs about the person of the Holy Spirit in the Trinity, and to continue thinking about what God does in the Sacraments.

ACTION

MSP to arrest the examination.

Candidate Gray was excused to a waiting room.

Moderator Presby called for a motion to approve Shawn Gray for ordination to MWS (seconded). Minimal discussion followed. TE Stephen McKinney-Whitaker (Derry PC, Hershey) spoke in favor of Candidate Gray, observing that Mr. Gray has been what they've needed as Director of Christian Education; he brings empathy and compassion, and will be a good fit as clergy.

ACTION

MSP to approve Shawn Gray for ordination to Ministry of Word and Sacrament.

After the vote, Candidate Gray was escorted back into the sanctuary. Moderator Presby informed him of the favorable outcome of the vote with the singing of the Doxology. The way is clear for Mr. Gray to be ordained by the Presbytery of Carlisle to Temporary Pastor at Derry PC the evening of Tuesday, May 28.

Moderator Presby asked TE Lorenz to offer a prayer; he invited those who are important to Mr. Gray to come forward. "We give thanks for your call to Shawn in ministry. For all he has experienced and learned – and all that he *will* experience and learn." Warm welcomes to the presbytery were extended.

TE Lorenz then reported that COM is keenly aware of changes coming to Board of Pensions (BOP). COM will meet with Emily Chutty, BOP Representative, and schedule additional meetings for pastors, clerks, and more; watch e-mail. He extended personal thanks for Lucy Bowerman – she's returning to COM!

Offertory

As a pick-up choir of 4 men and 4 women sang *What a Friend we have in Jesus*, \$235 was collected for PAW Packs, a program designed to provide meals to families within the Big Spring School District who might otherwise have nothing to eat on weekends or holidays. In gratitude, presbyters sang "Give thanks with a grateful heart..." and Moderator Presby led a Litany of Celebration:

"I celebrate the trust we hold, the spirit we share, the attitude of partnership. I celebrate that love lives among us, that God's spirit pervades our being, our community."

CALL TO DISCIPLESHIP

Commissioning – using a Commissioning Service for General Assembly from New Covenant Presbytery VM Tiedeck asked the previously-elected Commissioners to GA226 to come forward: RE Rose Jewell-Jordan (Faith-Immanuel PC, Harrisburg), RE Kemper Dyson (Middle Spring PC, Shippensburg), and TE Gene Gordon (Capital PC, Harrisburg); TE Katy Yates Brungraber (Validated Ministry – Evangelical Lutheran Church of America, Greencastle) joined via Zoom.

With the reading of the Great Ends of the Church, Commissioners were reminded of discipleship being a manifestation of the new life we enter through baptism – both a gift of grace (sufficient for our calling) and a commitment. Affirmed that God has called them to particular service, Commissioners showed their purpose by answering questions of discipleship to Jesus Christ as Lord and Savior: loving neighbors; working for the reconciling of the world; serving with energy, intelligence, imagination, and love; relying on God's mercy and rejoicing in the power of the Holy Spirit.

Members of the Presbytery of Carlisle answered their questions in the affirmative, promising to accept these Commissioners as advisory delegates to the 226th General Assembly, chosen by God through the voice of the church, to guide us in the way of Jesus Christ. Presbyters promised to support and encourage them as they seek to fulfill their responsibilities in this ministry.

Following a Commissioning Prayer that called upon the Holy Spirit to guide the whole church to join in love and service to Jesus Christ – "who, having gone before us, is coming to meet us in the promise of your kingdom" – Commissioners to GA226 were charged that "Whatever you do, in word and deed, do everything in the name of the Lord Jesus, giving thanks to God through him." -- Colossians 3:17
